By letter dated July 10, 2023, the Honourable Minister of Labour and Social Security pursuant to Section 11A (1)(a)(i) of the Labour Relations and Industrial Disputes Act of 1975 (hereinafter called "the Act"), referred to the Industrial Disputes Tribunal for settlement in accordance with the following Terms of Reference, the industrial dispute described therein: -

The Terms of Reference were as follows:

"To determine and settle the dispute between Excelsior High School on the one hand, and Daniel Riley on the other hand, over the separation of his employment."

#### **SUBMISSIONS AND SITTINGS:**

Brief was submitted by the aggrieved representative and four (4) sittings held between February 6, 2024 and October 1, 2024.

#### **REPORT TO THE TRIBUNAL:**

At the 3<sup>rd</sup> Sitting the parties agreed to engage in local level discussions. At the 4<sup>th</sup> Sitting the parties agreed to mediation with the assistance of a Tribunal Member who was not already involved in the determination of this matter. By letter dated December 20, 2024, the Company's representative informed the Tribunal that the parties have reached a settlement agreement, which had been signed by both parties, however, the copy was not attached.

On February 10, 2025, the Tribunal received letter of same date, from the Aggrieved's representative, concurring that the parties reached an amicable conclusion of this dispute.

#### **AWARD:**

The parties arrived at a settlement as stated in their letters dated December 20, 2024 and February 10, 2025 (copies attached). The specific terms of the agreement are not included in the Award as the parties did not disclose the settlement to the Tribunal. Accordingly, the Tribunal will discontinue proceedings and record the Award as settled, in terms agreed by the parties.
