#### REFERENCE:

By letter dated September 5, 2024, the Honourable Minister of Labour and Social Security pursuant to Section 11A (1) (a) (i) of the Labour Relations and Industrial Disputes Act (hereinafter called "the Act"), referred to the Industrial Disputes Tribunal for settlement in accordance with the following Terms of Reference, the industrial dispute described therein:-

#### **SUBMISSIONS AND SITTINGS:**

1. No Briefs were submitted to the Tribunal. At the first sitting of the Tribunal on December 4, 2024, the parties requested an extension for the submission of the Briefs. This request was granted. The parties also sought the Tribunal's assistance in facilitating a settlement. This request was also granted and December 16, 2024 was scheduled for mediation. December 17 and 18, 2024 were confirmed for hearing to continue in the event that mediation was unsuccessful.

#### REPORT TO THE TRIBUNAL:

2. On December 5, 2024, the Tribunal was verbally informed by the parties that the dispute had been settled and that the assistance of the Tribunal was no longer needed. A joint letter dated December 16, 2024, signed by the parties, was received on January 3, 2025, confirming the settlement.



#### THE AWARD:

3. The parties, having settled the dispute at the local level without the assistance of the Tribunal, have by way of a joint letter dated December 16, 2024 (copy attached) informed the Tribunal of the settlement. It is that settlement which constitutes the Award of the Tribunal.


