

#### REFERENCE:

By letter dated February 16, 2024, the Honourable Minister of Labour and Social Security pursuant to Section 11A (1) (a) (i) of the Labour Relations and Industrial Disputes Act (hereinafter called "the Act"), referred to the Industrial Disputes Tribunal for settlement, in accordance with the following Terms of Reference, the industrial dispute describe therein:-

The Terms of Reference were as follows:

"To determine and settle the dispute between Sales, Sales Management Consultancy Limited (t/a SSMC Express International) on the one hand, and Darnell Cleghorne on the other hand, over the termination of his employment".

#### SUBMISSIONS AND SITTINGS

Briefs were submitted by the Aggrieved Representative and two (2) sittings were held on May 28, 2024 and August 22, 2024.

#### SETTLEMENT AGREEMENT

At the 1<sup>st</sup> sitting of the Tribunal, the parties were encouraged and granted time to have discussions to ascertain whether the dispute could be settled. At the 2<sup>nd</sup> sitting, the parties informed the Tribunal that they were unable to resolve the dispute and sought the assistance of the Tribunal in accordance with the provisions of sections 12 (5) (b) of the Labour Relations and Industrial Disputes Act (LRIDA), which states:

5. "Notwithstanding anything to the contrary, where any industrial dispute has been referred to the Tribunal-





b) it may at any time after such reference encourage the parties to endeavour to settle the dispute by negotiation or conciliation and, if they agree to do so, may assist them in their attempt to do so:"

The Tribunal conciliated the dispute at the 2<sup>nd</sup> sitting which resulted in an agreement being reached by the parties. The agreement forms the basis of this Award.
